Please join us for the launch of Talmage Boston's new tome, *Baseball and the Baby Boomer: A History, Commentary, and Memoir*. The book signing will be on Thursday, December 4, 2008 at 6:00 at the museum.

Mr. Limmer and Judge Garth

The Bell County Museum lost two great supporters this summer.

E.A. Limmer, Jr. called "E.A." by some, "Early" by others, "Limmer," and "Mr. Limmer," died July 10, 2008. He loved dancing, Bell County, his church (Christ Episcopal Church), genealogy, his wife and many friends, and the museum. Throughout three decades, Mr. Limmer donated more than 1,800 artifacts in addition to a wealth of genealogical materials. He served on the Board of the museum for more than six years, helped in its restoration, and was very active in the Bell County Historical Commission. One of his greatest achievements was the publication of the massive two-volume *Story of Bell County*, first published by the Commission in 1988; he served as the book's editor-in-chief. We miss his regular visits to the museum, where he would often regale the staff with stories, many of which should not be repeated.

We also lost Bell County Judge John Garth, on May 6th, 2008. Serving as county judge for twenty years, Judge Garth stood at the helm of many progressive projects throughout the county, including the creation of the Bell County Expo Center and the restoration of the Bell County Courthouse. Judge Garth was also a huge supporter of efforts to restore the historic Carnegie Library building in the late 1980s, and helped to lay the seeds of success for the Bell County Museum. We remember him for his leadership, terrific sense of humor, and support for all things Bell County.
