Notice is hereby given that a regular special meeting of the above named Court will be held at **9:00 a.m.**, on April 2, 2018, with the meeting to be held in the **COMMISSIONERS' COURTROOM**, at the Bell County Courthouse, 101 Central Avenue, Belton, Texas, to begin on April 2, 2018 at **9:00 a.m.**, and continue thereafter until such business of the Court has been completed in accordance with Article 81.005 of the Local Government Code of the State of Texas. The following items of business will be discussed, to-wit:

1. Consider approval of minutes of March 27, 2018.
2. County Engineer
  - a. Consider Final Plat Approval of "Tanglewood Amending Plat #2" Being an amending plat combining lots 540 & 541 of the Tanglewood Subdivision and containing 0.90 acres, located within the City of Temple's ETJ, Bell County, Precinct 3.
  - b. Consider Final Plat Approval of "Beulah Bluff Phase III." Being a replat of lot 16, block 2, Beulah Bluff II together with 0.702- acres adjacent and located within the City of Harker Heights ETJ, Bell County, Precinct 1.
