

**AN ORDER OF THE BELL COUNTY COMMISSIONERS' COURT
ESTABLISHING FEES FOR SERVICES BY THE SHERIFF AND CONSTABLES**

WHEREAS, Local Government Code Section 118.131 requires the Commissioners' Court to set reasonable fees for official services by the County's Sheriff and Constables; and

WHEREAS, other fees are required by statute to be set by the Commissioners' Court;

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS' COURT OF BELL COUNTY, TEXAS, that the following fees be established for the services of the County's Sheriff and Constables, and the other fees are established as required by statute:
