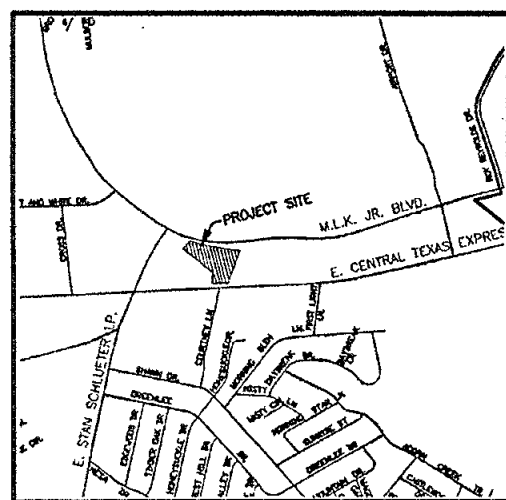

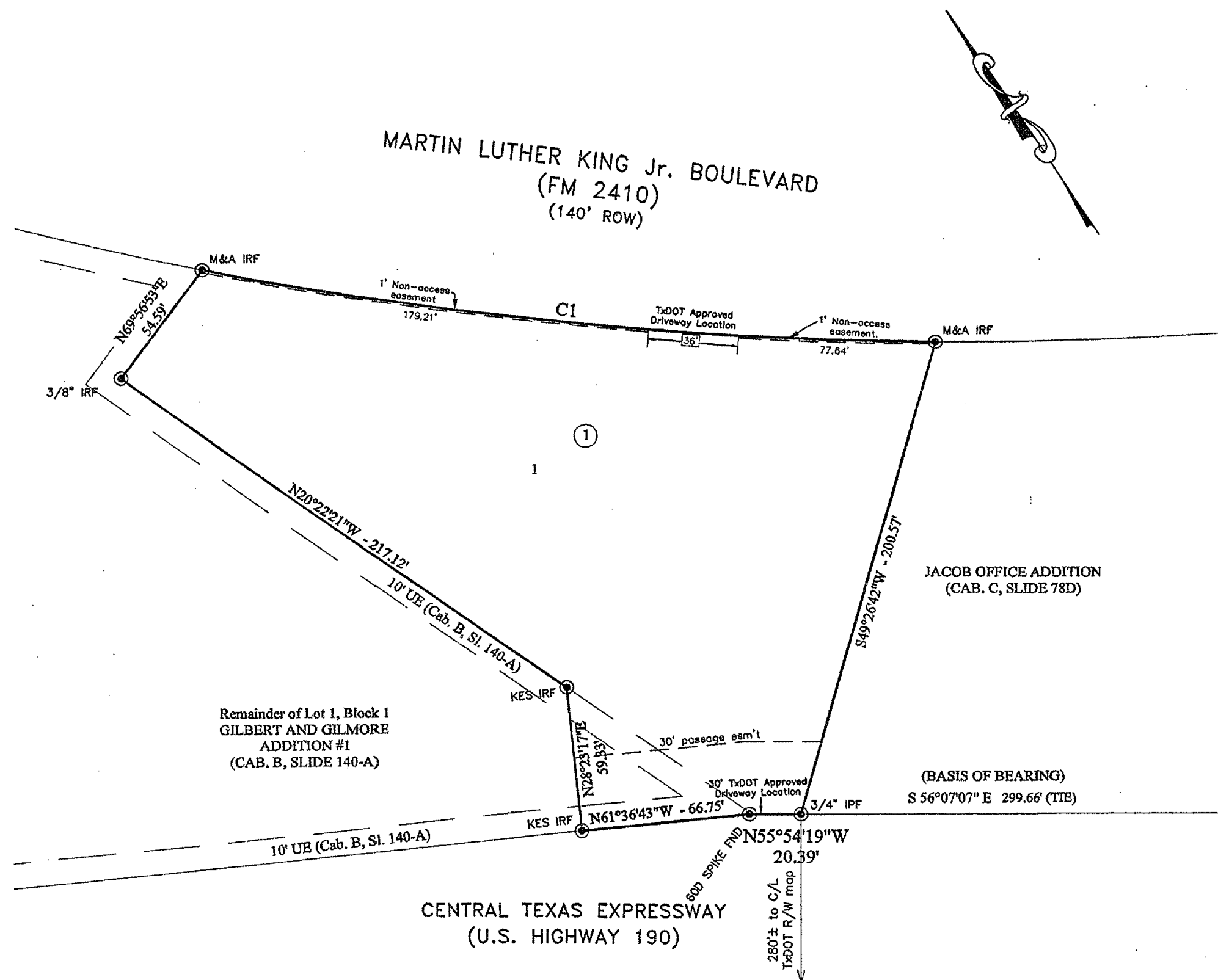
INSET "A"

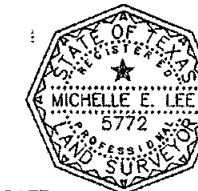
