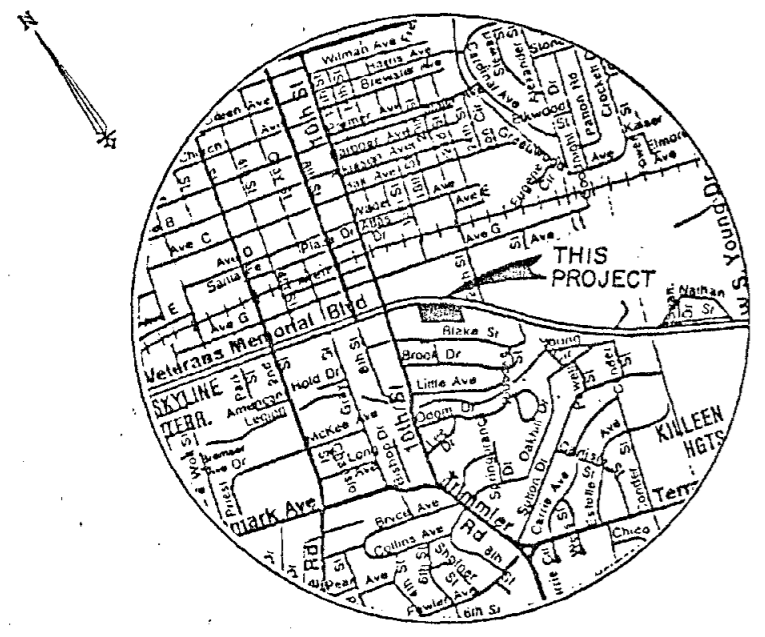
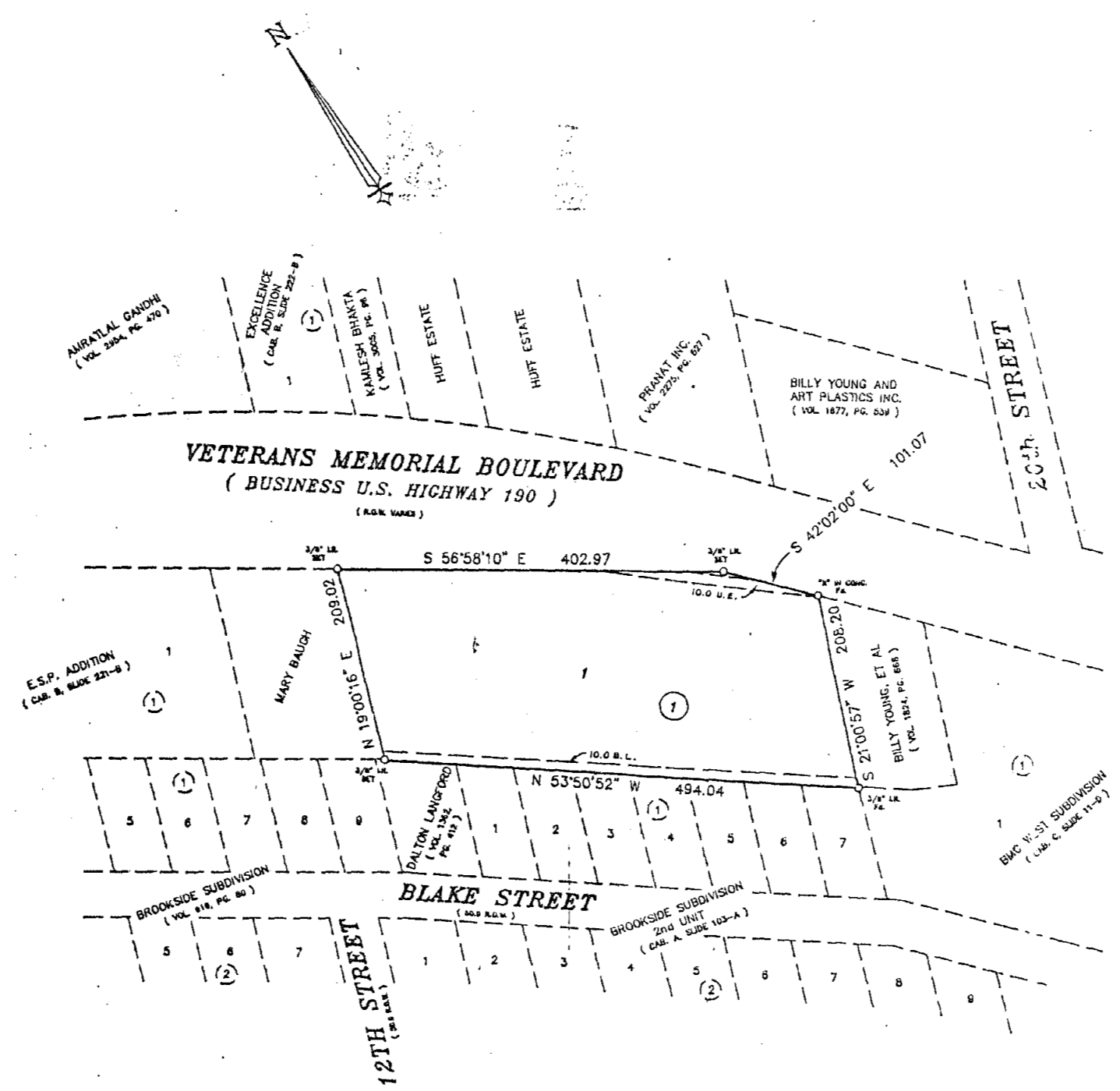

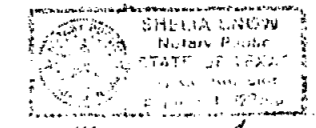
VICINITY MAP
