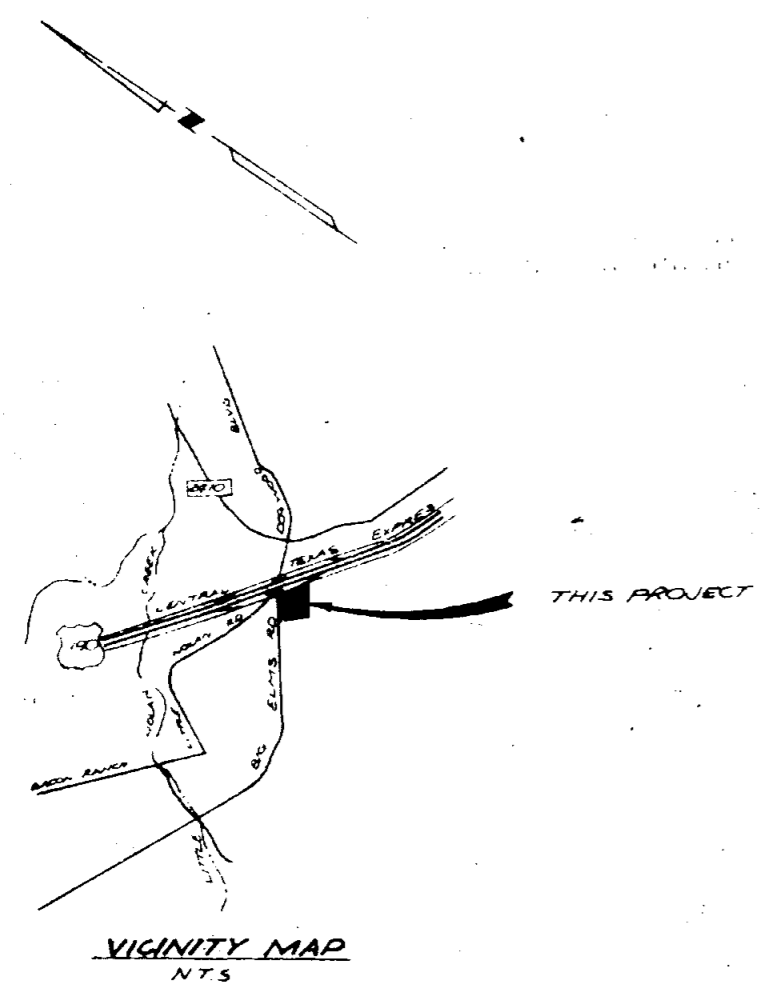
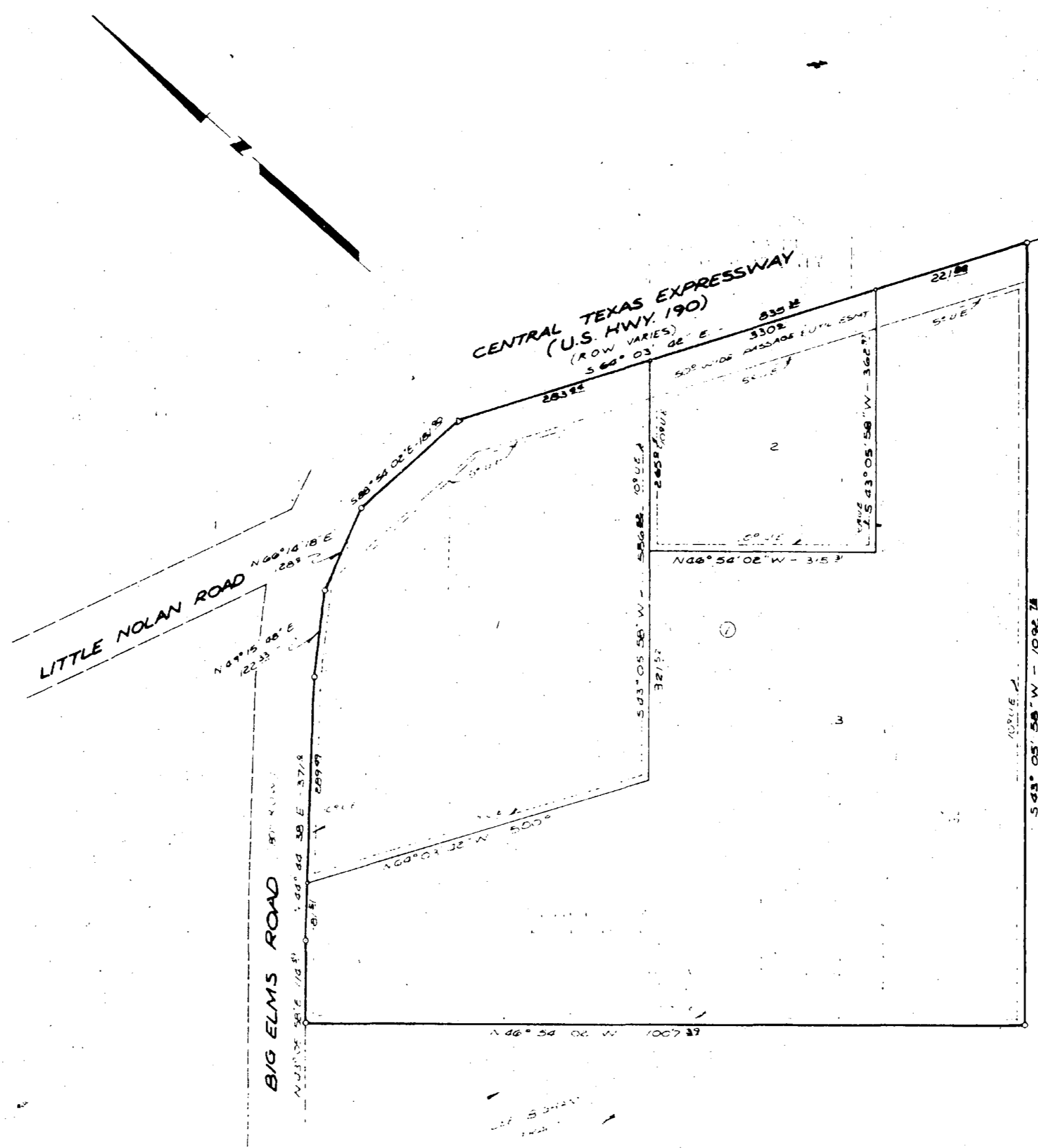

KNOW ALL MEN BY THESE PRESENTS, that Jim Trainum, Mildred Cloud and Frank Holbrook, whose address is P. O. Box 1712, Killeen, Bell County, Texas, being the owners of that certain 21.200 tract of land out of the R. Cunningham Survey, Abstract No. 158, which is more fully described in the plat of Trainum Addition, Killeen, Bell County, Texas, for the purpose of selling lots and blocks of land with reference thereto and for all other purposes do hereby dedicate to the City of Killeen, all streets, avenues, roads, drives and alleys shown on said plat the same to be used as public thoroughfares for the installation and maintenance of public utilities, when and authorized by the City of Killeen. The utility easements on said plat are dedicated to the City of Killeen for installation and maintenance of any and all public utilities which the City may install or permit to be installed or maintained.
