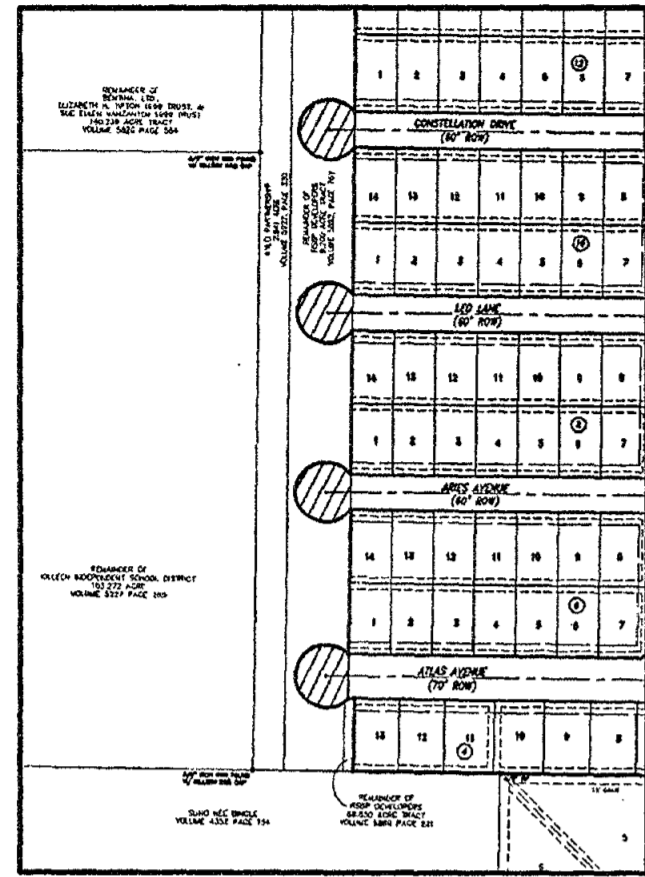

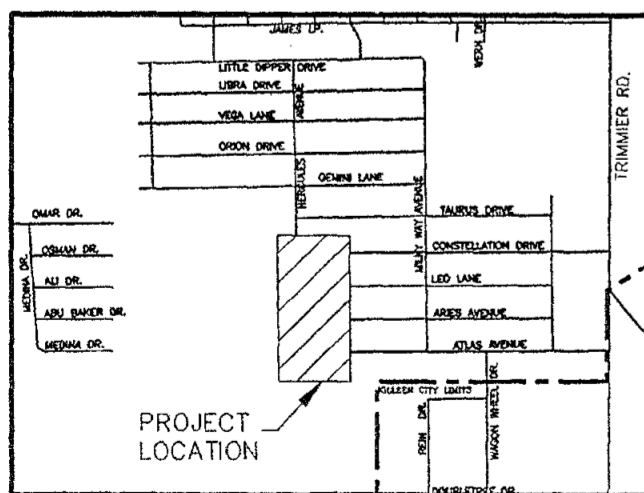

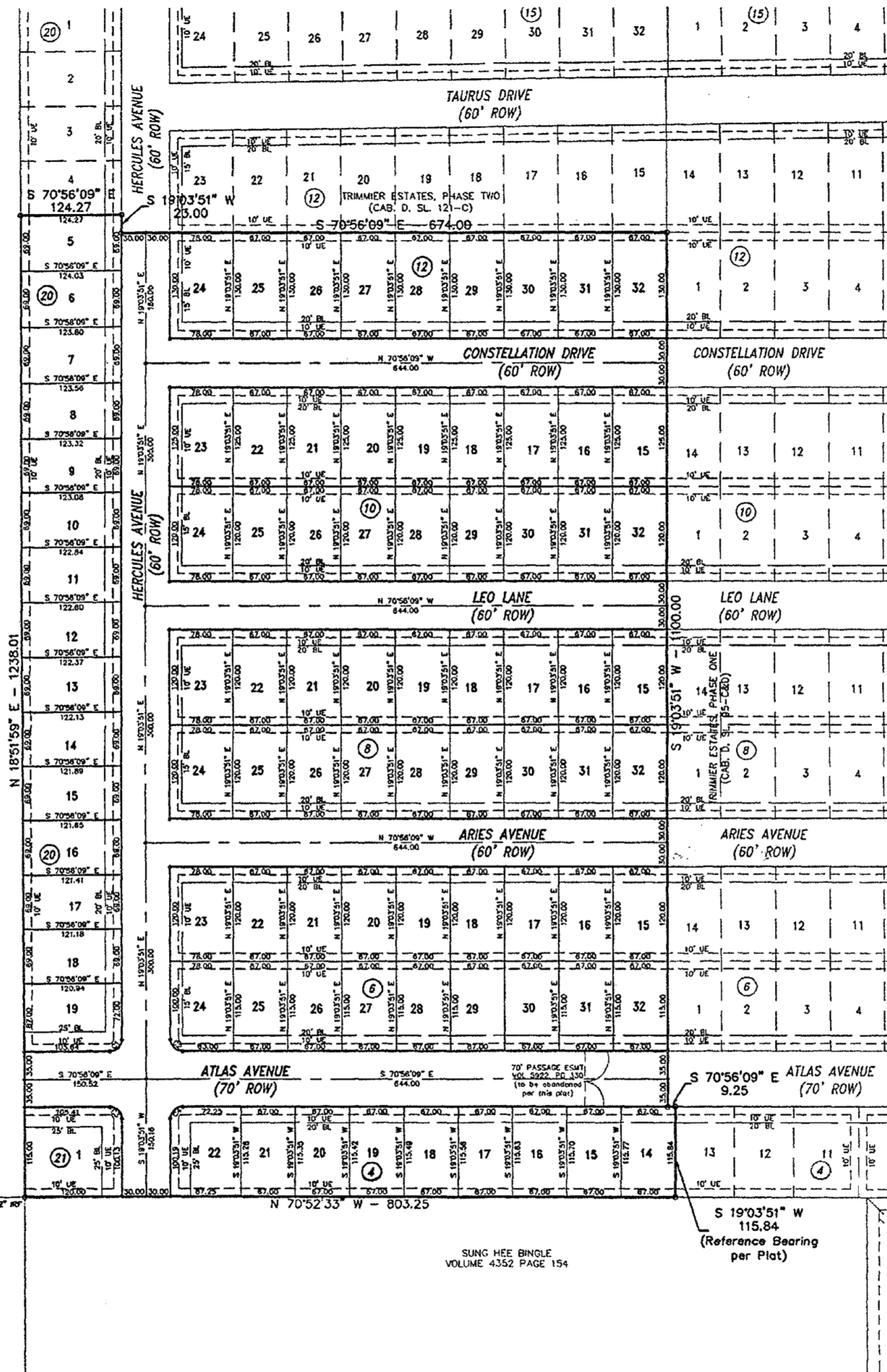
VICINITY MAP

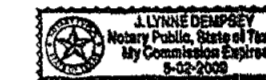
