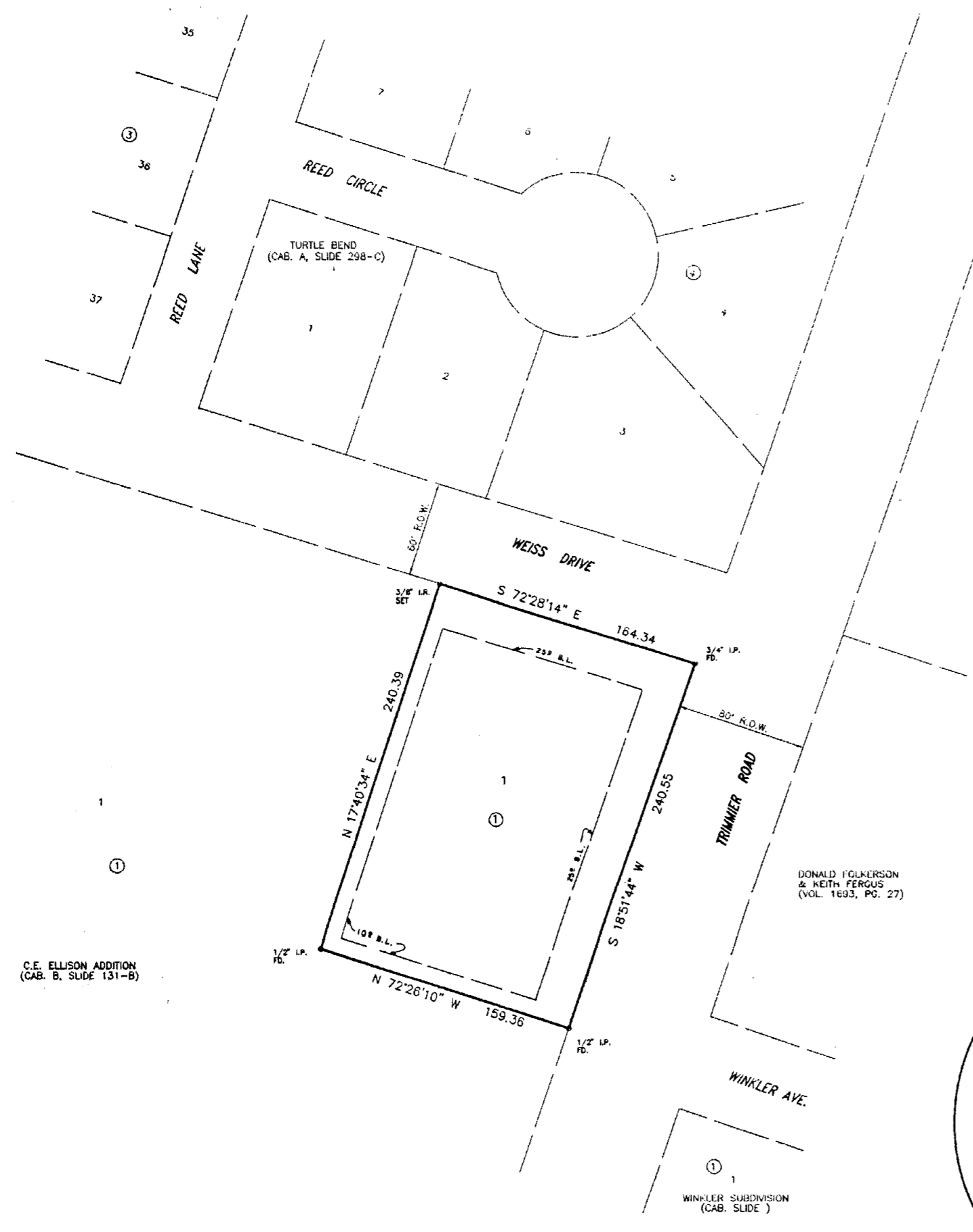

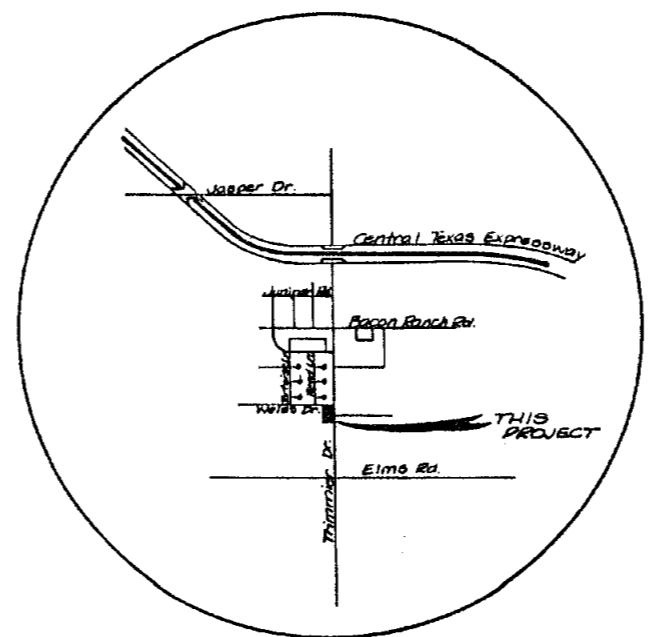

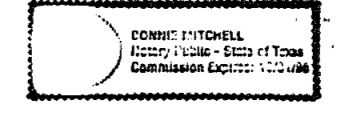
VICINITY MAP
